Students who need to appear for the backlog courses for which the theory exam is discontinued are required to get their exam forms checked from examination section.

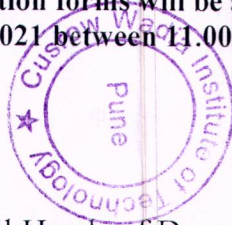
